### **BACKGROUND**

Building on the discussions during the East Asian Seas Congress 2024 held in Xiamen, China and around the 10<sup>th</sup> Our Ocean Conference in Busan, Korea, (secretariats to) regional organizations agreed to work together through a Regional Collaborative Network for MPAs with the view to developing concerted efforts to support country partners achieve their commitments towards the 30x30 targets of the Kunming Montreal Global Biodiversity Framework.

These regional organizations, which will now be called as 'the network' include, the Arafura and Timor Seas Ecosystem Action Program (ATSEA); ASEAN Centre for Biodiversity (ACB); Coordinating Body on the Seas of East Asia (COBSEA); Coral Triangle Initiative on Coral Reefs, Fisheries, and Food Security (CTI-CFF); Intergovernmental Oceanographic Commission - Sub-Commission for the Western Pacific (IOC-WESTPAC); International Union for Conservation of Nature (IUCN) Asia-Pacific and North-East Asian Marine Protected Areas Network (NEAMPAN), and Partnerships in Environmental Management for the Seas of East Asia (PEMSEA) and the South China Seas – Strategic Action Programme (SCS-SAP) Project

Among areas of potential collaboration are: building a common understanding of MPA and MPA Network initiatives in the region through mapping regional initiatives, sharing of existing tools and resources, linking existing knowledge platforms, enhancing communication of good practices and success stories, organizing joint capacity building and training, building country partner networks and elevating the profile of the East Asian Seas globally in a concerted manner.

As an initiative step, PEMSEA coordinates the group work to conduct a mapping exercise with some analysis to share information and knowledge on existing MPA and MPA related initiatives, tools and resources, partnership modalities and practices with key stakeholders that bring mutual benefits, social inclusion and transparency and lessons learned in tackling MPA issues in order to and build a deeper understanding of initiatives to strengthen MPA effectiveness in the EAS region and in support of respective regional strategic action programs or strategies.

The target for the exercise includes all practitioners, managers, planners and designers involved in global ocean governance from local to regional scales in the EAS and elsewhere.
